SECTION 4: First aid measures

4.1. Description of first aid measures

- First-aid measures general : IF exposed or concerned: Get medical advice/attention.
- First-aid measures after inhalation : Allow the victim to rest. Assure fresh air breathing. Give oxygen or artificial respiration if necessary. If breathing stops, give artificial respiration. Call a POISON CENTER or doctor/physician.

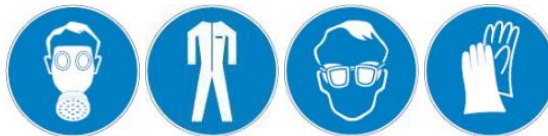
